1	<p>On Form C the definition of Affiliates is very broad. It works all the way up and down the chain for all projects with a contract value of \$50 million or more and where there was a dispute or claim in excess of \$5m over the prior ten years. This would potentially capture an excessive amount of information. Respondent requests that the first paragraph of part C.2. for Form C be amended as follows:</p> <p><i>“List and briefly describe all instances (including any resolution) during the last <u>5</u> 10 years involving Reference Projects <u>in North America</u>, or any other project with a contract price of \$50m or more, in relation to which any Major Participant or any of its Affiliate of any of them”</i></p>	RFQ: Form C	Exhibit C remains unchanged. Respondents should use their best efforts to capture the requested information and clearly identify in their response any gaps in information which is not being disclosed.
