Subject: RFP 023-19 Recyclable Materials Collections

1. This amendment (the "Amendment") is made by The Board of Education of Prince George's County and JLT Trucking, Inc. to the agreement dated June 26, 2019 (the "Agreement").
2. The purpose of the amendment is to add Dynamic Scheduling of Recyclable Materials Collection for a trial period of 120 days. The performance period for this service shall be July 20, 2020 – November 20, 2020. Lift charges for regular lift services as previously contracted on June 26, 2019, are suspended during the trial period. Service charges for lifts under the Dynamic Scheduling of Recyclable Materials Collection shall be billed in accordance with the following:

Lifts in excess of 2,078 will be billed based on the actual number of lifts conducted at the per lift rate of \$17.64		

3. Except as set forth in this Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with its terms set in the original agreement.
