### **SUBJECT: Rider Montgomery County Public Schools (MCPS) Contract #9186.18 – Asbestos Abatement Services at Various Locations**

The Agreement is amended as follows:

1. The Agreement is amended to extend the contract **under Rider Contract (MCPS) Contract #9186.18** from **July 1, 2023 to September 30, 2023**.
2. Except as set forth in this Contract Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with the terms set forth in the original agreement.
3. The contract award value for the extension period shall **not exceed \$150,000.00**.
