The Agreement is amended as follows:

- 1. The Agreement is amended to extend the contract **under** Rider Contract **(MCPS) Contract #9186.18** from **October 1, 2023 to February 23, 2024.**
- 2. Except as set forth in this Contract Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with the terms set forth in the original agreement.
- 3. The contract award value for the extension period is estimated at \$150,000.00.

All vendors must maintain an **active status in iSupplier** in order to conduct business with PGCPS. If your company is not active in iSupplier at time of signature, PGCPS will not sign the contract.

This contract is for the convenience of the Board and is considered by the Purchasing Department to be a "Non-Exclusive" use contract. The Board does not guarantee any usage. The Board will not be held to purchase any particular Brand, in any groups, prices or discount ranges, but reserves the right to purchase any item/items listed in the price schedule submitted.
