SUBJECT: Rider Montgomery County Public Schools (MCPS) Contract #9186.18 – Asbestos Abatement Services at Various Locations

The Agreement is amended as follows:

1. The Agreement is amended to extend the contract **under Rider Contract (MCPS) Contract #9186.18** from **October 1, 2023 to February 23, 2024**.
2. Except as set forth in this Contract Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with the terms set forth in the original agreement.
3. **The contract award value for the extension period is estimated at \$150,000.00.**

The Board will not be held to purchase any particular Brand, in any groups, prices or discount ranges, but reserves the right to purchase any item/items listed in the price schedule submitted.


