The Agreement is amended as follows:

1. The Agreement is amended to extend the contract under Rider Contract (MCPS) Contract #9186.18 from April 1, 2023 to June 30, 2023.
2. Except as set forth in this Contract Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with the terms set forth in the original agreement.
3. The contract award value for the extension period shall not exceed \$150,000.00.

The Board will not be held to purchase any particular Brand, in any groups, prices or discount ranges, but reserves the right to purchase any item/items listed in the price schedule submitted.

All other contract terms and conditions remain unchanged.




