SUBJECT: Rider Montgomery County Public Schools (MCPS) Contract #9186.18 – Asbestos Abatement Services at Various Locations

This amendment (the "Amendment") is made by the Board of Education of Prince George's County and **Southern Insulation, Inc.** under the MCPS 9186.17 agreement dated **April 25, 2022.**

The Agreement is amended as follows:

- 1. The Agreement is amended to extend the contract **under** Rider Contract (MCPS) Contract #9186.18 from July 1, 2023 to September 30, 2023.
- 2. Except as set forth in this Contract Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with the terms set forth in the original agreement.
- 3. The contract award value for the extension period shall **not exceed \$150,000.00.**

All vendors must maintain an **active status in iSupplier** in order to conduct business with PGCPS. If your company is not active in iSupplier at time of signature, PGCPS will not sign the contract.

The Board will not be held to purchase any particular Brand, in any groups, prices or discount ranges, but reserves the right to purchase any item/items listed in the price schedule submitted.
