The anticipated start date of the contract will be July 1, 2024 or a prorated period through June 30, 2025. Pricing shall be fixed for the initial contract period and each additional option period as agreed upon during the renewal period. The vendor may only petition for an increase in pricing on the anniversary date of each renewal period. Increases considered by the District will be evaluated by using the

Vendor. If the vendor requests price increases that exceed the
rate of inflation determined by the CPI, the contract may not be
renewed. The District reserves the right to accept or reject the
price increase and may choose to re-bid the contract if it is
deemed to be in the best interest of the District.
